“Basic Bird Watching” Course Offered in February

Are you a newcomer to Las Cruces and our “Land of Enchantment”? Do you have a friend, neighbor or golfing buddy who is? Do you want to start a new hobby or learn to identify the intriguing birds you see on your daily walk or in your backyard? If so, now is the time to sign up for the MVAS adult education course “Basic Bird Watching.”

Offered through the Community Education Program at Doña Ana Branch Community College, the course will include such topics as viewing equipment, birding books, general bird identification tips and backyard birding. Participants will receive a good introduction to the birds of southern New Mexico by seeing slides of southwestern birds and going on field trips to birding hot spots.

Four classroom sessions will be held on Tuesday evenings, February 3, 10, 17, and 24, from 7-9 PM, in the conference room at the new East Mesa campus of DABCC, off Roadrunner Parkway. There will be two, local Saturday morning field trips on February 7 & 14, and an all-day trip to the Bosque del Apache Wildlife Refuge on Saturday, February 21.

The cost is \$40 per person. Class size is limited to 15, so register early. 
Endangered Fish of the Southwest.

The Experience of a Lifetime—Polar


Bear Expedition. February 18. Polar bears, among the largest land mammals in the western hemisphere, inhabit the tundra region of the northern polar region. They weigh 600-1300 pounds but can reach over 2000 pounds. They feed primarily on seals, so they are very dependent on the pack ice. Changes in the timing of freeze up due to global warming are having serious impacts the southern distribution of this species. MVAS members Bob Tafanelli, Lorraine Schulte, and Michelle Santisteban will share with us their adventures in polar bear country around Churchill, Manitoba.

Field Trips



Field trips are free and open to the general public. Entry fees to some areas may be required and driving costs are shared. On all field trips wear appropriate clothing and bring water and binoculars.

Salton Sea. January 16 – January 19.

This special trip is scheduled for Martin Luther King holiday weekend in order for the largest number of people to be able to attend. The Salton Sea Wildlife Refuge is located on the southeastern edge of the Salton Sea. The nearest town is Brawley, California in the heart of the Imperial Valley. More than 375 species of birds have been recorded in the Salton Sea and Imperial Valley Regions. While shore birds and waterfowl are the most abundant birds at the refuge, there are numbers of raptors including Peregrine Falcons and Bald Eagles. Otero Mesa. February 28.

This will be an all-day expedition to one of New Mexico's most endangered landscapes — under consideration for extensive natural gas exploration and development, this vast expanse of Chihuahuan Desert grassland is home to pronghorn antelope, prairie dogs, and numerous grassland bird species. We will meet in the parking lot of the Bank of the Rio Grande on the corner of University and Telshor at 7:30 AM. We will need to carpool in SUV's; although the roads on Otero Mesa are improved dirt for the most part, some are pretty rough. Participants should bring lunches or snacks. We will drive from Las Cruces to Trans Mountain Road in El Paso and take the loop highway to the Carlsbad Highway. We'll head into Otero Mesa on the road that exits the Carlsbad Highway just west of the Immigration Check Station. Our route will go from the southern end of Otero Mesa — the Alamo Mountain area — north to the foothills of the Sacramento Mts. and return to Las Cruces through Alamogordo. Read the labels carefully, and if you can't find it, ask! If shoppers let the co-op know they are looking specifically for shade-grown coffee, the co-op is more likely to keep carrying it.

Christmas Count Report (204th National and 29th Las Cruces CBC)

Our Count was held on 14 Dec 2003. The weather was great, sunny and actually warm in the afternoon. We had 40 participating in the field plus a few feeder watchers.

The total number of species was low. We had 105 species reported, with three of those needing write-ups that have not yet been returned to me and three more species that need further discussion with the people who reported them. We will report somewhere in the range of 99 to 105 species for this year. I will base the following report on 102 species with the understanding that the actual report will be anywhere in the range of 99 to 105. We also have a count week Golden Eagle. Count week birds are not counted but they are listed so that the name remains on our list of birds on the Audubon web-page.

We were sixth from the bottom in the total number of species reported by us in the 29 years that the Las Cruces count has existed. This year's count was the lowest since 1987.

Surprisingly, the total number of birds counted was the highest that we have ever had with 62,000 birds. The count is rounded to the nearest hundred birds because it is still uncertain. The high count is due almost entirely to White-winged Doves. Over two thirds of all the birds reported (42,500) were White-winged Doves!

Rounding out the top ten species (in abundance) were American Crows, Rock Pigeons, White-crowned Sparrows, Mourning Doves, House Sparrows, Brewer's Blackbirds, House Finches, Red-winged Blackbirds, and Great-tailed Grackles.
